**IT IS HEREBY ORDERED:**

1. 2. The pre-hearing conference shall be held to discuss potential consolidation of the above-listed proceedings, simplify the issues, determine necessity or desirability of amendment to documents for purposes of clarification, simplification or limitation, determine stipulations, admission of fact and of contents and authenticity of the documents, limit the number of witnesses, determine propriety of the prior mutual exchange among the parties who have prepared testimony or exhibits, discuss intervention and decide other matters as may tend to expedite the disposition of the proceedings and to assure a just conclusion thereof.
