Dear Director Flanagan;

My office is legal counsel to Operating Engineers Local 520 ("Local 520"). This letter constitutes a Section 9 Written Objection and Request for Hearing pursuant to 820 ILCS 130/9, regarding the wage classification for "operating engineer" in the Counties of Bond, Calhoun, Clinton, Fayette, Greene, Jefferson, Jersey, Macoupin, Madison, Marion, Monroe, Montgomery, Perry, Randolph, St. Clair and Washington.

1. On July 15, 2022 the Illinois Department of Labor ("Department") posted a prevailing wage determination for the Counties of Bond, Calhoun, Clinton, Fayette, Greene, Jefferson, Jersey, Macoupin, Madison, Marion, Monroe, Montgomery, Perry, Randolph, St. Clair and Washington.

2. The "explanation of classes" for "operating engineers-building" and "operating engineer-highway" contains nine (9) groups.

3. Based on changes made to the Local 520 collective bargaining agreement, the number of groups has changed. There are now fourteen (14) groups under the classification "operating engineer-building" and thirteen (13) groups under the classification "operating engineer-highway."

4. The attached Exhibit A reflects the new groups of "operating engineer-building."

5. The attached Exhibit B reflects the new groups of "operating engineer-highway."

If the above-requested changes are not made, Local 520 respectfully requests a hearing on this matter pursuant to 820 ILCS 130/9.
