- o 140 people in plant, all made it to refuge structure areas and survived due to Safety Plan.
- o Benefits of Concrete Masonry Units (CMU) shelters

- NCMA Education and Research Foundation can provide detailed design, code compliance and budget for new and existing facilities.

• Comments by Cope Family:

- Alexandra Cope: Would like to see communication be a strong part of any plan.
 My brother did not know where to go as many other did not and that was detrimental. Main goal safety procedures, specific protocols, for these buildings, emergency would look like, that would be family's goal, for them to take responsibility
- Rachel Cope: We are talking about minimum standards, but big companies like Amazon will not have shelters without minimum standard requirements. They know their building structures fail in a tornado and then reconstructed the exact same building style that killed my brother. Without building minimum standard changes, no change will occur for companies like Amazon.

Comments by Capitol Development Board

Lisa Hennigh – Deputy Director of Construction spoke to the 2023 building code legislation that will apply across the state effective 1/1/2025 requiring all municipalities and counties to use baseline code, most current version. However, it does not address the tornado structure. The purpose was to address flooding and losing out on FEMA monies.

- o Sen. Ventura proposed IDOL conduct research of zoning and building code, and invite temp staff agency and/or warehouse operator to discuss training perspective
- o Rep Stuart requested clarity for building code enforcement
- Discussion of spring, summer and fall meeting. Next Meeting possibly week of April 8th due to legislature in session and in-person being held same location in Springfield. Poll will be sent out for date.
- o Open Meetings Act representative needed. Rep. Dan Ugaste will check with ethics officer to see if he already has the training if so, he is willing to act as OMA rep.
